Report from the Wilton Rural Neighbourhood Police Team. Apologies had been received.

Report from Wiltshire Councillor Mr Peter Edge. Attended latest CATG meeting, currently against a 20mph speed limit unless it is enforceable. Trials have shown a reduction to 20mph reduced the average speed by 1.6mph.

The speed limit on Skew Rd will be reviewed.

A community issue has been raised requesting a crossing on the A36.

SWWAB meet on 16th October at Mere, Jane Scott will be attending.

There are grants available for projectors etc, Clerk requested the info is sent to her.

Cllr Edge opened the meeting at 7.47pm

Quidhampton PC authorised the funds raised may be kept in the PC special projects account which currently has a balance of 1p.

Clerk to speak to Mr Burgess re authorising the work.

Clerk has received a request for a tennis court to be built at the recreation ground. Clerk to speak to Wilton tennis club re this request. Clerk

13/114 To receive an update from the recent CATG meeting concerning a raised path in Lower Rd and other issues requested by Quidhampton PC.

Raised path – a road safety audit determined a raised path is not feasible. A new traffic engineer starts in October, Clerk to arrange a meeting with Chairman and Wilts Cllr Edge. Clerk has submitted a request

for CATG to put Skew Rd forward for the C and Unclassified road review as well as a request for a 20mph speed limit.

Skew Rd - Highways will request a metrocount of traffic speed in Skew Rd.

20mph - Currently WC are consulting on 20mph speed limits, Clerk has emailed the link and asked ClIrs to respond as individuals. Pilot schemes in Wiltshire showed a reduction of 1.6 mph when a 30 was reduced to 20mph.

Clerk also enquired as to when the speed limit changes will be implemented along the A3094, Highways will look into this but it should be this year.

Highways Agency have said no to putting a right turn in at the Park Wall traffic lights. As there is no room for an extra lane it would impact on all traffic added to the eastbound traffic having to wait for the traffic turning right.

13/115 Sign decluttering. To consider a request from WC to look at excessive road signs and if there are any to request they are removed.

Quidhampton PC resolved that no action should be taken as there is not an excess of signs.

Flood seminar on 2nd October – Cllr Taylor (Flood Warden) and Mr Cater (CEV) will attend.
