

## Ratified minutes of a meeting of Quidhampton Parish Council on 27<sup>th</sup> March 2012 at Quidhampton Village Hall.

Present; Cllrs Bass, Cripps, Lovett, Taylor and Tyler. Mrs C Churchill (Clerk). Wiltshire Cllr Beattie, PC Jung and 5 members of the public.

Ms Drewett from Quidhampton Mill raised the speed limit on the A3094. It was explained that this was briefly discussed at the last meeting and QPC agreed to discuss the speed limit after the limit has been reduced – it is currently 60 and will be reduced to 50mph. Ms Drewett wishes the limit to be reduced to 40mph.

Ms Lovett asked if the PC had been in contact with Lord Pembroke and Netherhampton due to the accidents at the raceplain corner.

Clerk confirmed she hadn't contacted either party on this as that area is outside the area concerned.

Clerk is trying to confirm the boundary as part of the A3094 is within the boundary for Wilton Town

Clerk has spoken to Highways and they stated that any requests for a further reduction should be sent to Highways during the consultation period. It is then likely a report will be drawn up to look into the request, it was clarified that any report would delay the reduction.

Clerk suggested that all accidents in recent years are listed to help the case.

Cllr Lovett suggested Ms Lovett contact Netherhampton PC.

12/026	Neighbourhood Policing report. PC Jung reported Criminal damage to vehicles on village, need to encourage people to report crimes. Ms Tilbrook will place an article in the newsletter. Netherhampton Church has had roof stolen again. PCSO Spacey now joined regular police, currently in training.. New PCSO starting soon.	
12/027	Receive a report from the C.E.V. for Quidhampton. Mr John Cater has produced a draft plan. Plan has been circulated and was discussed. Mr Cater wishes to undertake a survey to ascertain facilities and skills available within the community. Mr Cater asked that all Cllrs are members of the emergency group, this will be discussed at a future meeting. Mr Cater will draft a questionnaire and Clerk to approve on behalf of QPC before it is distributed.	Clerk
12/028	Report from Wiltshire Councillor Richard Beattie. WC budget approved, Govt grant down by £3million, costs up by £29million, WC continue to get rid of buildings and staff to protect front line services. WC is a priority creditor for Icelandic bank, hope to get 98% back. Core Strategy for South Wilts has been approved. Imery's site identified for a waste transfer station. Land Command still ongoing. SWWAB met on 29/2/2012 and 22/3/2012, held a youth forum and agreed a budget for Jubilee celebrations. Royal visit in May, would like something from every village. Waste collection now fortnightly, any problems with non emptying please contact Cllr Beattie. Looking into four way pedestrian crossing at Wilton traffic lights. Cllr Beattie is not standing at the 2013 election.

The proposed road closure has been advertised in the Quidhampton newsletter which was delivered to all properties, there has been no communication to the Parish Clerk on this. Funding of £1000.00 was applied for and awarded. Cllr Taylor was thanked for representing QPC.</li> <li>2. Quidhampton Bop on Monday 4<sup>th</sup> June. A small committee to organise this has been established and is headed by Mr Ron Smith. No further information was available. Cllrs agreed that as the Bop is exclusive (adults only and limited and entry charge) then PC can't consider funding. The original plan was for the Bop to be self funding.
