(i) **Safety issues along Lower Rd between Footshill and Skew Rd junctions.**

Due to the weather no meeting has taken place with Highways.

(ii) **20mph speed limit in the village.**

WC have now approved a policy and each Area Board may put forward two sites for consideration of a 20mph speed limit per year. The policy has been circulated.

To confirm that Lower Rd is to be put forward for consideration.

(iii) **Speed limit review in Skew Rd.**

The metrocount is still awaited, Clerk has chased and been informed it is on the list but following issues with the highways contractor there are several which are outstanding.

(iv) **Pedestrian safety issues in Skew Rd.**

Delayed until after the metrocount has been done.

(v) **Update from the CATG meeting held on 20th January 2014.**
